## The matter of Approving the Minutes for February 12, 2019

## <u>The matter of Discussing the Fiscal Year 2017-2018 Audit Report with Auditor Steve Tuchscherer.</u>

**AUDITORS REPORT:** Steve Tuchscherer, the City's Auditor from Umpqua Valley Financial, LLC, gave the auditor's report in relation to the HRA's funds for the last year. He talked briefly about challenges faced by other cities, when they allow too many constraints in relation to restricted funds. It helps to have resolutions that identify what commitments Cities have in relation to those funds. Harrisburg handles their funds really well. He congratulated the board for cranking up and using the Redevelopment funds in the manner that Harrisburg is doing. It's a great way to build a community. He talked briefly about how they as auditors use some very complicated spreadsheets, to populate all the numbers that they use in an audit report. He's very thankful that Harrisburg doesn't have a lot of account numbers within the HRA Budget; that is helpful to how they work the audit.

 Downey motioned to approve the HRA's Fiscal Year 2017-2018 Audit Report, as presented by Auditor Steve Tuchscherer. She was seconded by Boese, and the HRA Board motioned unanimously to approve the HRA's Fiscal Year 2017-2018 Audit Report.

## Others:

- Downey expressed dismay about loaning money for The Voo remodel, only to see a for sale sign on the building.
- However, after discussion, Latta realized that the sign she was referring to was an old one that they haven't taken down yet. The money is definitely being utilized by The Voo; their construction was ongoing.
