I am sure most Harrisburg residents are aware that former City Administrator, Brian Latta, left this last September to take a job as City Administrator in Dallas, Oregon.

The Harrisburg City Council has hired me as a part-time, Interim City Administrator. I started in late September and have enjoyed getting to know the city staff, many Harrisburg citizens, and the City Council members. I am very glad to be working with a staff, Mayor and City Council who are very focused on working as a team to continually improve the city.

In the meantime, the city has been recruiting for a new, permanent City Administrator who hopefully will start shortly after the New Year.

There are numerous community improvement projects pending, including new sewer and water lines, that aren't very exciting, but absolutely crucial to a growing and vital community. Others, like some downtown street and property improvements going on now (such as the former Odd Fellows Hall, Ron-D-Voo (now called The Voo), JB Woodworks and others) are more visible and represent innovative partner-ships between the city, the private sector and state agencies such as the Oregon Dept. of Transportation (ODOT).

All of these projects (and many more not mentioned here) require close coordination and cooperation between the many partners. They are all moving forward, but often at a pace that is difficult to predict. Suffice it to say here that by next summer or fall, you should see a lot of activity in the downtown and along 3rd St. (Hwy 99).

I would urge everyone to stop by and see our recently re-opened Harrisburg Library at 354 Smith Street. New facilities, new materials and new hours. Come in and meet or get reacquainted with our great library staff and volunteers.

The last two months of the year are busy but fun ones here in Harrisburg. Headed by the Annual Light Parade (Dec. 7th), there are numerous events and activities that capture the Harrisburg small town spirit. I would urge all Newsletter readers to get involved with the Harrisburg Holiday Happenings.

Winter billing rates are in effect. Starting in November and continuing through April residential customers shall be billed for sewer based upon the amount of water used during that billing cycle. Water Bond Projects

The City of Harrisburg and Harrisburg voters approved the issuance of \$7,500,000 in bonds in November 2017. The Public Works Director and City Engineers have been hard at work ever since, working on all of the survey and design work required for all of projects that were approved. The improvements included the following:

* The construction of two new water reservoirs, two water filtration systems, a new City well, the removal of Well No. 5, and finally, the replacement of approximately 3.5 miles of main waterline.

Significant progress has already been made in terms of engineering and design work. The water master plan creation took substantial time, and has been preliminarily accepted by the State of Oregon, plus, the financing of the project was completed in August 2019. A preliminary schedule for the next year's remaining project milestones are as follows:

- * Summer 2019—Survey & Design work for phases 1-3 of waterline replacements
- * Fall 2019—Begin design work for water treatment facilities and water storage tanks
- * Winter 2019—Bid phase 1 of waterline distribution piping replacements
- * Spring 2020-Award waterline distribution piping replacements
- * Fall 2020-Bid and award for construction of water treatment & storage facilities

Library Amnesty Program

The Harrisburg Public Library is offering a "forgiveness program" for patrons who have overdue Harrisburg Library materials and late fines. The program will be offering three different opportunities.

*For patrons who have lost materials, you can pay the replacement cost with non-perishable food items during the months of November to December. For each non-perishable item, \$1.00 will go towards the replacement cost of \$5.00 for paperback books and \$10.00 for hardbacks.
