1. **ENTRY:** Theme 'The Polar Express.' Must have holiday lights, business/organization/individual name on both sides of float, not exceed 13'6" height and 15'0" width and have a signed waiver form to participate.
2. **FEES/DEADLINE for Junction City/Harrisburg:** \$20 covers all the parades. Submit the registration form and fee to the TC Chamber at 355 West 6th Ave, Junction City, OR 97448 by Wednesday, November 28th. If you have a vehicle club, the fee is \$20 per vehicle or \$50 total, whichever is less.
3. **FEES/DEADLINE for Monroe:** No fee. Please submit the registration form to the TC Chamber at 355 West 6th Ave, Junction City, OR 97448 or Monroe Fire Department by Wednesday, December 7th.
4. **SANTA:** Limit of **one Santa** per parade to be selected by the Chamber Board and Monroe Fire Dept.
5. **CANDY:** Walkers **may hand out** store-purchased candy or treats. **No throwing** from floats or vehicles.
6. **WALKERS:** At least two walkers aged 14 or older are required with each entry to ensure safety.
7. **RIDERS:** Please do NOT jump off or on floats on the parade route or exceed float capacity.
8. **DRIVERS:** Must possess a valid driver's license and liability vehicle insurance and be at least 18 years old.
9. **RAILROADS:** When crossing the tracks, be aware of the length of your float as trains are active.
10. **ALCOHOL:** Cannot be consumed by parade participants before, during the parade, or in the line-up area.
11. **PUBLIC SAFETY:** No activities that could endanger public safety. Move float to the side if you break down.
12. **LITTER/WASTE:** Entries shall NOT cause trash or debris to be left on roads or sidewalks. Animal entries must have a pooper-scooper follow them to clean up waste from your animals.
13. **STAGING:** 6:15-6:45 pm. Check-in at the registration desk in the staging area. Judging 6:30-6:50 pm.

Registration: Mail this completed form and **\$20 fee** (covers all parades) to Tri-County Chamber, 355 W 6th Ave, Junction City, OR 97448 by **November 28, 2022**. If participating in the Monroe parade only, there is no fee and deadline is December 7th; form can be sent to the Tri-County Chamber or Monroe Fire Dept.

Event Waiver: In consideration of the Tri-County Chamber of Commerce, the Monroe Rural Fire Protection District, the cities of Junction City, Harrisburg, and Monroe (hereinafter referred to as the **Light Parade**), I/We hereby waive and release any and all rights and claims of any nature that I/We may have against the Light Parade, their officers, employees, agents, assignees, licensees, volunteers, and cooperating entities for and against any and all injuries and damages of any nature which I/We may suffer while taking part in any activities connected with this event. This release shall be binding upon my/our heirs, executors, administrators, and/or assigns. I/We have read and agree to abide by all Light Parade guidelines including:

- Must have holiday lights and business/organization/individual name on both sides of the float.
- Entry cannot exceed 13’6” height and 15’0” width.
- Limit of **one Santa** per parade. Must be approved in advance by the Chamber (or Fire Dept in Monroe).
- Walkers **may hand out** store-purchased candy or treats. **No throwing** from floats or vehicles.
- At least **two walkers** aged 14 or older are required with each entry to ensure safety.
- Please do **NOT jump off or on** floats on the parade route or **exceed the capacity** of the float.
- Drivers must possess a **valid driver’s license** and **liability vehicle insurance**, be at least **18 years old**, and have **signed and dated this waiver** form.
- When crossing tracks, be aware of the length of your float. Trains are active. **Do NOT stop on/near tracks.**
- **Parade participants cannot consume alcohol** before, during the parade, or in the line-up area.
- **No activities that could endanger** participants or spectators. Move float to the side if you break down.
- Entries shall **NOT cause trash or debris** to be left on roads or sidewalks. Animal entries must have a **pooper-scooper** follow them to clean up waste from your animals.

(If vehicle club, fee is \$20 per vehicle or \$50 total, whichever is less. Fee of \$20 covers all parades.)
