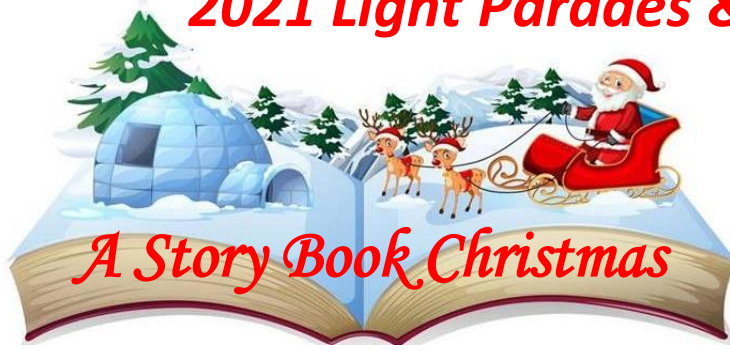


2021 Light Parades & Business Decorating

1. **ENTRY:** Theme is **A Story Book Christmas**. Must have holiday lights, business/organization/individual name on both sides of float, not exceed 13’6” height and 15’0” width, and have a signed waiver form to participate .
2. **FEES:** \$15 flat fee covers participation in all three parades. Please submit the \$15 fee and registration form to the Tri-County Chamber of Commerce at 341 West 6th Ave, Junction City, Oregon 97448 by December 1st.
3. **SANTA:** Limit of **one Santa** per parade to be selected by the Chamber Board.
4. **CANDY:** Walkers **may hand out** store purchased candy or treats. **No throwing** from floats or vehicles.
5. **WALKERS:** At least two walkers age 14 or older are required with each entry to ensure safety.
6. **RIDERS:** Please do NOT jump off or on floats on the parade route or exceed float capacity.
4. **DRIVERS:** Must possess a valid driver’s license and liability vehicle insurance and be at least 18 years old.
5. **RAILROADS:** When crossing the tracks, be aware of the length of your float as trains are active.
6. **ALCOHOL:** Cannot be consumed by parade participants during the parade or in the line-up area.
7. **PUBLIC SAFETY:** No activities that could endanger public safety. Move float to the side if you break down.
8. **LITTER/WASTE:** Entries shall NOT cause trash or debris to be left on roads or sidewalks. Animal entries must have a pooper-scooper follow them to clean up waste from your animals.
9. **STAGING:** Check in at the registration desk in staging area. **Junction City**—6th Ave in front of High School.
Harrisburg—9th St in front of High School. **Monroe**—Call Fire Dept at 541.847.5170 for information.
