1. Re-inspection fee - \$60.50 per inspection
2. Each additional inspection - \$60.50 per inspection
3. Inspections for which no fee is specifically indicated - \$60.50 per inspection
4. Electrical investigation fee - \$80 per hour
5. Additional plan review required by changes, additions or revisions to plans - \$80 per hour
6. Inspections outside of normal business hours - \$90.75 per hour (minimum charge of 2 hours)
7. Master Electrical Permit – Set-up fee of \$100 / \$60.50 per hour for inspections (see separate application)

\*No licenses required. Licenses are required for all other installations.
